## 2025 Call for Award Nominations

The Mid-Atlantic Association of Museums (MAAM) encourages members from the field to submit nominations for the following categories of awards to recognize organizations and individuals throughout the Mid-Atlantic region for their leadership, career achievements, creativity, and best practices. You can access the <u>Award Nomination Application online</u>.

### NOMINATION REVIEW TIMELINE

- A. July 11: Nominations due-Extended Deadline: July 25, 2025
- B. July 14-25: MAAM Annual Conference Awards Committee reviews and evaluates nominations
- C. August 15: Notification of Award Committee decisions
- D. September: Public Announcement of Award recipients
- E. October 28-30: Recognition at 2025 Annual Conference

#### THE KATHERINE COFFEY AWARD

The Katherine Coffey Award is given each year by the Mid-Atlantic Association of Museums to an individual in the Mid-Atlantic region to recognize distinguished achievement in the museum field. The Coffey Award ceremony is held annually at the MAAM Annual Conference.

Eligibility and Selection Criteria for the Coffey Award

- Nominees should have worked as a paid museum professional for at least 10 years in a principal position.
- Nominees should have been (or be currently) employed in the Mid-Atlantic region during the period of principal contribution for which the award is being given.
- Nominees should demonstrate accomplishment in their role and a record of service to the profession on state, regional, national, and/or international levels.
- Nominees should also have a proven record of service to the community in which the museum is located.
- Self nomination is <u>not permitted</u> for the Katherine Coffey Award.
- Includes one letter/cover letter from the nominator explaining why you believe the person should be nominated for the Coffey Award

 Includes two additional letters of support, separate from the cover letter (total of 1 cover letter and 2 letters of support), attesting to the nominee's contributions.

## THE MAKING AN IMPACT AWARD

This award honors museums and institutions for developing either a program, exhibition, or special project that displays responsiveness and resourcefulness and have resulted in creative change for their organizations and a positive impact on their communities. Self nomination is permitted.

Eligibility and Selection Criteria for the Making an Impact Award

- Overall quality of project, exhibition, program (please be specific about describing the project audience that has been impacted and how).
- Demonstrates responsiveness, resourcefulness, and creativity of the nominated program, exhibition, or special project
- Displays a positive change within the institution and the community
- Includes supporting materials, such as photos, work samples, visitor impact data (e.g., surveys, feedback), demonstrating the project's effectiveness
- Includes one letter from the nominator explaining why you believe the institution should be nominated for the award (preferably someone with direct knowledge of the nominee's work).
- A second Letter of Support from an additional supporter, <u>distinct from the nominating letter</u>, attesting to the institution's contributions to both the museum field and their community.

## THE EMERGING MUSEUM PROFESSIONAL AWARD

An award celebrating outstanding emerging professionals who have worked or volunteered in the museum industry for fewer than 7 years.

Eligibility and Selection Criteria for the Emerging Museum Professional

- Has worked or volunteered in the museum industry for fewer than 7 years.
- Shows outstanding performance, innovation, or leadership either within their own museum or across the wider museum community
- Self nomination is <u>not permitted</u> for the Emerging Museum Professional Award
- Includes a one page cv or brief bio of the nominee.

Recipients will be announced publicly in September and recognized during the 2025 Annual Conference in Pittsburgh, PA, October 28-30, 2025.
